Cookie Policy

1. Introduction

Ins & Outs English Services, with place of business in Trieste, via Francesco Trevisani 6 (hereinafter "Data Controller"), as data controller, informs you, in compliance with art. 13 EU Regulation No. 2016/679 (hereinafter "GDPR"), that your data will be processed as detailed in the attached Privacy Policy (available at) as well as through the use of cookies and related technologies (hereinafter "Cookies") when using our website, https://ins-n-outs.com (hereinafter "Website"), which was created and is managed using the Wix platform (www.wix.com; hereinafter, "Wix"). In the following, we explain the nature, use and purposes of Cookies.

2. Definitions

Cookies are small pieces of data stored on a site visitor's browser. They are typically used to keep track of the settings users have selected and actions they have taken on a site, and they may be first-party (installed by website owner) or third-party (Cookies in use on website but produced by third parties).

Types of Cookies:

- Essential Cookies: These Cookies enable core functionalities such as security, verification of identity and network management. These Cookies cannot be disabled.
- **Functional Cookies**: These Cookies collect data to remember choices users make to improve and give a more personalized experience.
- Analytics Cookies: These Cookies help us to understand how visitors interact with our Website, discover errors and provide a better overall analytics.
- Marketing Cookies: These Cookies are used to track advertising effectiveness to provide a more relevant service and deliver better ads to suit your interests.

Duration:

- **Session Cookies**: These Cookies are temporary and expire once you close your browser (or once your session ends).
- **Persistent Cookies**: This category encompasses all Cookies that remain on your hard drive until you erase them or your browser does, depending on the cookie's expiration date. All persistent Cookies have an expiration date written into their code, but their duration can vary.
